Institute

The Austrian Institute for International Affairs (oiip) is an independent, non-partisan research institute situated in Vienna. Founded in 1979, the oiip has established itself as Austria's leading institute in the field of international politics. Positioned at the juncture between academic and policy-oriented research, the oiip and its researchers observe and analyse dynamics and trends in international politics, examine crises and their backgrounds, identify risks and opportunities and develop solutions. Work

Research Areas

1) Security Politics

Our research focuses on issues of security and security politics: we address the questions of how and by whom security, insecurity and risks are defined and whose security is considered to be relevant. We analyse security policies, institutions, technologies and practices from the perspective of critical security studies, including feminist and postcolonial approaches. Additionally, we research the forms, characteristics, causes, processes and effects of terrorism, extremism, radicalization, as well as hybrid threats to Austrian, European and global security. We take different ideological orientations as well as individual, group and state actors into account.

2) Europe and the World

Our research focuses on the EU's relations with the Western Balkans, Turkey, North Africa and the Middle East, as well as with China, the USA and the Global South. We examine how EU accession processes, the European Neighborhood Policy and the EU's Foreign Policy instruments work and how they are discussed and perceived in the partner states and we analyse the foreign policy of these countries vis-á-vis the EU.

3) Political Regimes & Foreign Policy

Democracies around the world are facing multiple challenges. Our research deals with democracy, democratization and reform movements as well as the background of the rise of populist, illiberal and authoritarian forces and their impact on the functioning of state and political institutions. We also examine whether and how populism and autocratization affect the shaping of foreign policy and international relations.

4) Multilateralism and the World of Geopolitics

The liberal world order is in flux. Emerging international and regional actors are challenging the dominance of the West and Western-style institutions. Multilateral organizations such as the UN, the OSCE, but also NATO are facing major challenges. Our research starts here and examines the impact of these changes on various levels of international politics. It addresses the question of the future of international organizations and the international system and examines the implications for warfare and peacebuilding. We also examine economic, social and systemic drivers behind geopolitics. We take a critical approach that sees power politics as the outcome of cultural, social, economic and political processes.

5) Migration, Transnationalism & Diaspora

Our research explicitly examines migration not from a security perspective, but as a social, political, cultural and transnational phenomenon. Our research encompasses two key areas: the intercultural, political and economic coexistence of migrants in Austria and the transnational connections they have. Additionally, we examine the role of migration in international and bilateral relations. We are also researching the policies individual states pursue towards their diaspora, how they are implemented and the factors driving these policies.



Research 2024

The following pages list the research activities conducted at the Austrian Institute for International Affairs - oiip throughout 2024. These include funded research projects, published project reports, policy analyses, policy briefs and working papers that are part of one of our cooperations with the Austrian Ministry of Defense and the University for Continuing Education Krems (UWK). The research activities and policy papers are structured along our major research areas and the research topics we have pursued. While the research areas highlight the continuity of the institute's foci, the topics vary from year to year according to specific projects, developments in the world and the expertise of our researchers.

1. Security Politics

1.1 Security Regimes

Project:

Post-War Europe: How to Rebuild our Security Architecture?

In the run-up to the 35th anniversary of the Charter of Paris and the 50th anniversary of the Helsinki Accords, the project puts the achievements and failures of Europe's security architecture under scrutiny and looks for solutions to overcome the deep divides in existing institutions that shape this architecture. oiip & 8 European think-tanks.

The Reconstruction of Mosul: Traditional Civil Society, Non-Governmental, State and International Actors

Situated in the North of Iraq, Mosul, the second largest city in the country, has been the centre of multiple developments. By June 10, 2014, Mosul was captured by the so-called Islamic State (IS) and subjected to its brutal rule, which caused massive disruption to its infrastructural, economic and socio-political texture. Once liberated in December 2017, Mosul illustrated the challenges Iraq faces in overcoming the devastating experience of the Islamic State. The project analyses the micro-(individual), meso-(city) and macro-(national and international) levels, it maps and traces the initiatives promoted by traditional authorities, non-governmental organizations, state and international actors in the process of reconstruction.

Pacifist and Neutral, or Passive and Naive? Japanese Pacifism, Austrian Neutrality and the Construction of Alternative Foreign Security Policies

In a homogenizing international politics characterized by states choosing sides and upping defense spending, what could an alternative foreign security policy look like? Austria and Japan are dissimilar in many respects but share a commitment to foreign security policy narratives that go against the flow in contemporary international politics: neutrality and pacifism. While these are in some respects dominant narratives in their respective domestic contexts, internationally, neutrality is increasingly uncommon and pacifism has always been seen as an unrealistic option for

states. Examining these two cases of "alternative" foreign security policy narratives, this project sought to elucidate the fault lines between dominant foreign security policies and foreign security policies that offer a substantial alternative.

Policy Analysis 2 / 2024

Free Rider or Strategic Balancer? Austria vis-à-vis NATO and Russia. US – Perspective on Austrian Neutrality Politics

Russia's invasion of Ukraine on 24 February 2022 highlighted the fragility of peace and security in Europe. The resurgence of war in Europe prompted a reassessment of the security postures of traditionally neutral countries. Norms on military spending and assistance have been shattered, leading to Finland and Sweden reversing decades of military non-alignment to join NATO. Even Switzerland is eyeing a strategic overhaul and is considering joint exercises with NATO (Revill, 2022). Despite Sweden and Finland's decision to join NATO Austria remains committed to neutrality. The public debate on Austria's strategic culture has remained largely the same and policymakers in Vienna have not changed their stance on NATO. Russia's war in Ukraine has underscored Austria's need to reevaluate its policy of neutrality and strategic approach vis-à-vis NATO and Russia.

Policy Analysis 3 / 2024

Identity Continuities, Far-Right Acquiescence and the "New" and the "Old": Finnish and Swedish NATO Accession and Neutrality

With Finland and Sweden's accession to NATO, the number of neutral or non-aligned states in the EU has been reduced to three: Austria, Ireland and Malta. How did Finland and Sweden's shifts come about? It argues that: 1) Both the Finnish and Swedish policy shifts were underpinned by identity considerations, identities that remain largely the same under NATO membership as under non-alignment. 2) The far right's acceptance of NATO membership has been a mix of opportunism and broadly ingrained views of Russia. 3) Particularly in Sweden, neutrality has become seen as a thing of the past and alliance membership as new and exciting, with possible implications for how neutrality is understood internationally. The paper also examines the neutrality debate in Austria, with particular attention to the notion of neutrality as Austrian identity, the role of the FPÖ and the potential risks for "neutral Austria" going forward. This policy analysis was produced as part of the cooperation between oiip and the Ministry of Defence.

Preparing for a Rainy Day: What Can EU Member States Learn from Finland's Approach to Resilience?

The EU faces growing threats from geopolitical tensions, pandemics, hybrid warfare and climate change. These challenges require resilience that extends beyond military readiness to include robust civilian preparedness. In the 21st century, the need for rapid responses to complex threats has increased, demanding civilian sector involvement to ensure national security. Finland's Comprehensive Security Model provides a valuable framework for crafting a unified EU resilience strategy.

1.2 Extremism, Radicalization and Terrorism

PARTES PARticipatory Approaches to proTEcting placeS of Worship

PARTES proposes a comprehensive prevention model for the protection of PoW (Prisoners of War) that is evidence-based, inclusive and participatory. In order to effectively combat the security threats posed to PoW, it is essential to understand the underlying violent extremist phenomenon and its concrete manifestations in relation to these targets; involve faith-based communities in policies and measures and educate the broader population with regard to toxic extremist rhetoric but also to the features and manifestations of various faiths.

SEEDS (Security Education by Empowering Democratic Strength) KIRAS Study

Russia's invasion of Ukraine has fundamentally altered the understanding of security in Europe and Austria, as well as the European security architecture. In light of new military threats, it is crucial to make democratic societies more resilient and defensible. National defense and security now encompass not only the protection of territorial sovereignty but also the defense of democratic order and the rule of law. In Austria, the concept of comprehensive national defense (ULV) addresses this approach. Alongside economic, civil and military defense, intellectual national defense (Geistige Landesverteidigung) is a key component, focusing on raising awareness and imparting democratic values. Schools play a vital role in conveying and sustainably anchoring democratic resilience. The SEEDS (Security Education by Empowering Democratic Strength) project

addresses this research and educational need. The project focuses on determining young people's knowledge base and information sources on security policy issues through participatory research workshops with students.

Effects of the 7/10 Attack on the International Normative Order

The horrific attacks orchestrated by Hamas on October 7th, 2023, followed by Israel's counter-offensive in Gaza, gave birth to a number of controversies in the context of world politics. Recent discussions in the international relations literature claiming a progressive weakening of the international liberal order appear suitable for further exploration in the context of this developing conflict. In particular, this policy paper sets elements of the Israeli counter-offensive in Gaza against leading principles of international humanitarian law, the Genocide Convention and the international law duty of care of occupying powers. It finds initial indications of an apparent weakening of the international liberal order due to the prioritisation of security considerations in the West. Hate Crime and Extremism in Austria in the Background of the Middle Eastern Conflict

Drawing on the research insights of the EU-funded research project PARTES, the policy brief outlines the sharp rise in hate crimes in Austria following the outbreak of the conflict in Gaza in response to the Hamas terrorist attack of October 7, 2023. The paper outlines the modus operandi

behind these hate crimes and the nature of the narratives and motivations accompanying them. Austrian Jewish communities are particularly affected by these incidents, as increasing anti-Israel sentiments often translate into acts of antisemitism. At the same time, anti-Muslim narratives and increasing anti-Muslim racism have led to intensified hostilities against Muslim communities. The paper proposes several policy recommendations. As an umbrella term encompassing a wide spectrum of threats with complex and multidimensional features, the notion of hybrid threats remains inherently vague and amorphous. This lack of clarity presents significant challenges for policymakers, who must constantly identify potential dangers, anticipate risks and formulate effective responses to safeguard their polities and populations. Consequently, a persistent sense of insecurity has become a defining characteristic of the current European security landscape. The book calls for a critical examination of the underlying assumptions, core concepts and broader political implications of this security paradigm. It argues that the hybrid threat narrative demands a re-evaluation of what security means in contemporary Europe and how it is operationalised.

The Dialogue Residency was initiated by the Austrian Foreign Ministry following the study visit of a delegation of the Egyptian National Council for Human Rights to Vienna in June 2024. The Dialogue Residency aims to provide the members of the Council with long-term guidance and capacity building and human rights training for law enforcement, particularly in the context of migration and deportation, as well as conditions in detention facilities, including pre-trial custody and the treatment of children and young offenders. Further discussions explored the role of ombudspersons, with a focus on oversight and the effectiveness of complaint mechanisms, as well as probationary services, including legal frameworks and lessons from the Austrian model.

How the West Loses Public Opinion in Europe's Neighbourhood

The working paper examines the decreasing normative impact of the United States and the European Union in Europe's immediate neighbourhood. Project:

Perceptions of China and Russia – Transatlantic rifts, overlaps, and prospects for cooperation

The project brought US scholars Dina Smeltz (Vice President for Public Opinion and Foreign Policy, Chicago Council on Global Affairs) and Carla Freeman (Senior Expert on China, US Institute for Peace) to Austria, for public discussion events at the University of Krems and the Amerikahaus in Vienna (US Embassy). The involved oiip scholars also engaged in Zoom discussions with Tina Kempin Reuter (University of Alabama) and Guenter Bischof (University of New Orleans). The

project found that US voters' perceptions of China and Russia are mainly divided along partisan lines, as Republicans view China as more threatening, and Democrats Russia. Republicans are less likely to support aid to Ukraine. US voters' support for US alliances in Europe is slightly decreasing, and expectations for Europeans to align with (on a bipartisan basis) increasingly confrontational US China policy are growing.

J.D. Vance's Vice-Presidential Debate Performance: From Controversial to Civil

J.D. Vance exceeded expectations in the vice-presidential debate, presenting himself as a polished and moderate Republican, a stark contrast to Donald Trump's chaotic rhetoric. His composed performance, focused on key Republican issues like inflation and immigration, helped him appeal to moderate conservatives and independents. Tim Walz, though respectful and passionate, struggled to effectively expose Vance's controversial past statements and hardline views. While the debate is unlikely to shift the race significantly, Vance's performance may have softened his image, positioning him as a viable future leader of the Republican Party.

The MAGA Comeback: Europe Braces for a New Trump Era

Donald Trump's landslide victory in the 2024 US presidential election cements the dominance of the MAGA movement and reshapes transatlantic relations. With Republican control of Congress, Trump now wields unprecedented power, bringing uncertainty for Europe. His administration is expected to demand higher European defense spending, reimpose tariffs and take an unpredictable approach to Ukraine. Multilateral cooperation will likely give way to a transactional relationship, challenging the EU's stability. To navigate this shift, Europe must unify its strategy, bolster defense capabilities and reduce reliance on US leadership. While Trump's return poses risks, it could also push the EU toward long-overdue strategic independence.

China's Role on the Multilateral Level – What Is Changing Due to China's New Strategy Papers? What Are the Implications for Europe and Austria?

The Chinese government's long-term goal is to replace the US as a global leader. However, China's foreign policy strategy is not aimed at overturning the current international order, but rather at increasing China's influence on the multilateral system and its institutions. Beijing is looking for allies and is primarily targeting the countries of the "Global South". Beijing promises a new world order that is more strongly oriented towards the interests of developing countries. Despite its rhetorical outstretched hand to the states of the "Global South", China's reform proposals are sometimes problematic for these states. China, for example, is only thinking about new non-permanent members without veto power in the UN Security Council, which frustrates India in particular.

3.3 Opposition and Social / Protests Movements

Women in Politics: Challenges and Opportunities in Authoritarian Regimes

This project explores the challenges and opportunities of women's political participation in authoritarian regimes, with a specific focus on Serbia. By analysing the impact of authoritarian structures on female political representation, the project investigates whether women's involvement remains symbolic or can genuinely influence policymaking. The study formulates four hypotheses regarding limited engagement, symbolic representation, policy influence and resilience in overcoming obstacles. Employing a mixed-methods approach - including document analysis, interviews and legislative reviews - this research aims to provide a nuanced understanding of women's political roles in Serbia. The findings contribute to the broader discourse on gender equality and political representation, offering insights for policies that promote inclusivity in authoritarian contexts.

Survival Strategies in the Middle East: Foreign Policy in the Service of Regime Security. The Cases of Egypt and UAE

The policy analysis examines foreign policy making in Egypt and the United Arab Emirates (UAE). It highlights how internal power dynamics and the interaction between formal institutions and informal networks shape foreign policy making in these two different types of Middle Eastern autocracies. The study identifies the politically relevant elite coalitions and their impact on decision-making. In both regimes, the circle at the top of the power pyramid is rather small and characterized by informal and family ties. A small and homogeneous elite promotes cohesion but also limits the diversity of opinions. The royal elite in the UAE and the military and intelligence elite at the core of the al-Sisi regime in Egypt pursue their own economic interests in the service of regime security and stability. The paper identifies areas where the regional and foreign policies/interests of the two friendly countries and their elites diverge. Dollar Democracy: Uncovering the Risks of Monetary Meddling in US Foreign Policy

Since the Supreme Court of the United States effectively abolished campaign finance laws, money has flooded into the electoral system at unprecedented levels, prompting politicians to recalibrate their positions to court the necessary funds. Research indicates that as a result, the representative process has been distorted, with the US political apparatus becoming more responsive to wealth than to the collective will of the electorate. Studies also show that this development has been accompanied by the rise of "dark money," which is legally unaccounted for and often originates from undisclosed sources. Building on these findings, this policy analysis argues that the influx of untraceable funds allows adversarial governments to exert significant influence with minimal oversight, putting the United States at grave geopolitical risk. It is imperative to address these malign financial practices as a serious threat to US sovereignty by reinstating stricter campaign finance and anti-corruption laws to ensure the protection of democratic integrity and national security. The UN Summit of the Future (September 2024): Which Opportunities for the OSCE?

The UN Summit of the Future, scheduled for 22-23 September 2024, brought together the United Nations' 193 member states under the theme "multilateral solutions for a better tomorrow." Despite a sour mood in New York City against the backdrop of the war in Ukraine and the Israel-Gaza conflict, the Summit was supposed to act as a 'reset'. The OSCE, which is "multilateralism in action", was hoped to use the event and its aftermath to promote its remarkable contribution as a 'regional arrangement' under Chapter VIII of the UN Charter and its thirty-year concrete cooperation with the UN. The paper presents ten recommendations for the Ministerial Declaration at the December 2024 Council. The Geopolitical Priorities of the United States in the Context of the Presidential Election

The 2024 presidential elections have had significant implications for the Grand Strategy of the United States. The paper anticipated that a second Trump administration could shift US-Europe relations towards a more transactional dynamic, deprioritizing European security amid a strategic pivot to the Indo-Pacific. The paper suggests that these developments necessitate a reassessment of Europe's security and defense responsibilities. The continent must prepare for a reduced US commitment by strengthening its strategic autonomy and clearly articulating its priorities to Washington. Simultaneously, Europe must navigate the broader geopolitical landscape, including growing US-China tensions and global critiques of Western foreign policy, particularly in response to conflicts such as the Israel-Gaza war. The New Geopolitical Formation in the Wider Horn of Africa: Consequences for Europe

The ongoing conflicts in Sudan, Somalia and Ethiopia significantly destabilise the Wider Horn of Africa and impact the broader Middle East and North Africa (MENA) region. These conflicts, rooted in fragmented statehood and exacerbated by internal ethnic, regional and political divisions, threaten regional stability through increased migration and disruptions in the Red Sea. The conflicts are deeply internationalised, involving military engagements from neighbouring countries and attracting global powers due to significant geostrategic stakes. Traditional Western influences are waning. Instead, new actors like China, Russia and various Gulf States are heavily engaged in the region. For Europe, the instability in the Horn of Africa presents urgent challenges, primarily related to migration, the security of maritime routes and potential spillover effects in neighbouring regions like Egypt. Addressing these issues requires enhanced political engagement, addressing humanitarian needs, reforming peacekeeping efforts and strengthening security cooperation. Europe's response should be robust and coordinated, aiming to mitigate immediate threats and contribute to long-term stability in the region, reflecting the complexity of the intertwined interests and ongoing conflicts. Limited Politics: The EU's Geopolitics-Migration Nexus

In recent years, the EU has significantly shifted its geopolitical strategy towards the Neighbourhood. While it previously relied on soft power and the export of norms, its approach is now increasingly shaped by Realpolitik. Russia's war of aggression and irregular migration have influenced the EU's geopolitical re-orientation. The focus is now on a migration-driven geopolitics that emphasizes the externalization and militarization of borders. The EU has been forging agreements with third countries along migration routes to curb migration movements far beyond its borders. This has led to cooperation with autocratic regimes and has indirectly fostered lawless spaces and violence at Europe's periphery. Critics argue that this approach limits the EU's ability to act while allowing other geopolitical players to expand their influence. Recent Arrivals in Austria: Newly arrived Refugees from Syria and Other Third Countries on the Austrian Labour Market

The majority of newly registered persons entitled to asylum and subsidiary protection (KON/SUB) at AMS Vienna come from Syria. Due to the increasing number of asylum applications from summer 2022, this group accounts for more than 20% of all unemployed clients or clients in training. Due to their origin, they have a high probability of staying, while later refugee cohorts usually have lower levels of education, poorer health outcomes and a lower socio-economic background. This can make sustainable labour market integration more difficult and require additional support services, for example, in the areas of health and literacy. Against this background, a mixed-method survey identifies factors and barriers to sustainable labour market integration, such as conditions of flight, extended interim stays and low levels of education, as well as de-skilling, precarious employment and experiences of discrimination.

What Obligations Do States Have Under Article 6 of the International Covenant on Civil and Political Rights in Regard to Climate-induced Migration?

Climate change has led to the displacement of millions of people across the globe and human relocation based on changing environmental conditions is not a recent development, with such movement occurring throughout much of human history. However, the changing structure of the international legal system over time has affected the conditions under which people are able to migrate to different areas and the legal claims they have to protection in another location. This has led to a gap in the current state of research on legal protections for migrants, particularly on the basis of climate change and environmental degradation. The aim of this project is to provide a clearer understanding of states' legal obligations towards climate-induced migrants under international law. The primary research question of the project is, "What obligations do states have to provide protection to climate-induced migrants under international law?"

The Impact of Migration on International Relations: Power Relations, Security and Migration Diplomacy Reexamined

Migration has become a key issue in international relations (IR), reshaping power dynamics, security policies and diplomatic strategies, particularly within the European Union. While the concept of "migration diplomacy" has emerged, the field of migration in IR remains dominated by Eurocentric perspectives, often framing migration as a security threat, especially since the post-9/11 era and the 2015 refugee crisis. This securitization has led to new challenges, such as pushing migrants toward dangerous routes and reinforcing misconceptions linking migration to terrorism and conflict. Recent research challenges these assumptions, showing that migration does not inherently heighten security risks and that expanding refugees' rights can reduce radicalization. The migration-security nexus highlights the need to broaden discussions beyond security concerns, emphasizing the complex, interconnected nature of migration, development and peace. The Bosnian Diaspora in Austria Between Political Apathy in the Country of Origin and New Forms of Political Participation in the Host Country.

With approximately 168.000 people, the Bosnian diaspora is one of the largest diaspora communities in Austria. Due to the size of the diaspora, the close historical, cultural and economic ties, as well as the geographical proximity, a new and hybrid form of political transnationalism has emerged. Notably, the strong ethnic fragmentation in the country of origin is also reflected in the diaspora, which remains largely divided along ethnic lines. The Policy Brief provides a general overview of the Bosnian diaspora in Austria, with a particular focus on its political participation. The decline of political engagement in the country of origin has created space for alternative forms of political involvement in the host country. These alternative forms of engagement within the Bosnian diaspora serve as a prime example of a modern and democracy-affirming model of transnational political participation in democratic immigration societies. The project included interviews with Prague city migration and integration authorities and Czech scholars, as well as exchanges at the Czech foreign ministry. A final report was compiled, a policy-related article published, a podcast recorded and a lecture at a joint event in Prague with the Konrad Adenauer Foundation was delivered by the project lead.



The year 2024 marked a global democratic paradox. While elections took place across the world, including the EU and US, democracy itself seemed increasingly fragile. Nobel Peace Prize laureate Maria Ressa warned, "We will know whether democracy lives or dies by the end of 2024."

This warning felt especially urgent in the Western Balkans, where democratic backsliding has persisted for over a decade. In light of ongoing international support for regimes balancing between autocracy and democracy under the guise of stability, we saw a need for honest debate.

Key questions included: How can stagnation and authoritarianism be countered? What tools exist to address electoral fraud in Serbia or the lack of media freedom across the region? And how can the EU signal real support for recent pro-democracy movements as part of a revitalized enlargement strategy? In the 19th and early 20th centuries, European power politics were largely dominated by the so-called "Eastern Question", the division of the territory of the dying Ottoman Empire. Rising nationalisms, territorial ambitions and the struggle for power and influence between Russia, the Western powers, Austria-Hungary and the Ottoman Empire fueled unrest, instability and conflict, ultimately leading to the First World War. Today, more than 100 years later, Southeastern Europe once again seems to be at the centre of European geopolitics and power politics. Since the beginning of the war in Ukraine, Russia and the West have been engaged in an indirect struggle for influence in the region. They are joined by Turkey and new players such as China.

CHRISTOPHER J. FULLER, University of Southampton Dr Christopher J. Fuller's talk stemmed from his latest project, The Hammer and the Scalpel: America's Precision Ethos and Culture of War, which explores not just the military aspects of precision warfare, but also its political, linguistic, aesthetic and social impact upon the US and its allies. High-Value Targeting (HVT) has been a cornerstone of American counterterrorism for two decades. Beyond eliminating targets, it aims to deter future threats and reassure citizens of

Strategic Outlook and Future Directions: Key Takeaways from the Mini-Retreat

During the mini strategy retreat (Mini-Clausur) in February 2025, participants assessed the institute's position within a changing national and international landscape, identifying core competencies and key partnerships. They aligned individual project plans with the oiip's strategic goals, focusing on flagship publications, projects and events. Breakout sessions explored funding and sponsorship strategies, innovative outreach methods for new target groups and the development of an oiip Academy curriculum for training and courses.



oiip & The Institute of International Relations Prague - IIR Workshop, Prague 11-12 March 2024 What Does it Take to Do Policy Research and Address the Right Audiences?

During the joint workshop between the oiip and the Prague Institute for International Relations (IIR) in March 2024, participants explored key aspects of conducting policy research and effectively addressing target audiences. Discussions focused on structural constraints and opportunities in Austria and the Czech Republic, as well as the composition of academic and policy-oriented research in both institutes. The workshop included presentations of ongoing research projects and an exchange on methodologies for effective policy analysis. Participants examined the

balance between theoretical and applied research and strategies for increasing outreach. On the second day, concrete areas for cooperation were defined, including potential joint research projects, events and collaborations in international research networks. The concluding session focused on outlining the next steps for continued cooperation and joint initiatives.

Workshop, 12 September 2024

Old and New Levers in EU-Neighbourhood Relations

The workshop explored shifting EU-Neighbourhood dynamics in two focused sessions.

The first session, "The ENP is dead; long live the ENP!", featured Elisabeth Johansson-Nogués (Institut Barcelona d'Estudis Internacionals), Erzsébet Nagyné (University of Public Service, Budapest) and Jan Daniel (Institute of International Relations, Prague). They offered global and Central/Eastern European perspectives on the European Neighbourhood Policy (ENP) in light of recent challenges such as the war in Ukraine.

The second session, "Migration as a driver of EU-Neighbourhood relations?", examined how migration influences cooperation with neighbouring countries. Contributions came from Judith Kohlenberger (oiip/WU Vienna) and Federica Zardo (Krems University of Applied Sciences), with moderation by oiip Director Cengiz Günay. Discussions addressed ENP governance, regional approaches and the long-term implications of EU migration agreements.

The workshop was made possible through the kind support of the Anna Lindh Foundation and was organised in cooperation with the University of Krems.

The Future of Competitive Authoritarian Regimes

The consolidation of competitive authoritarian regimes (CAR) has entailed state capture, building a partisan judiciary, constitutional amendments, the limitation of democratic freedoms, control of the media, polarizing nationalist rhetoric, the harassment of oppositional parties, politicians and supporters. Although in time societal support for most CARs has been decreasing and oppositional forces can seriously challenge the incumbents, populist authoritarian leaders are usually able to mobilize their electorate and remain in power. Affective polarization and clientelism have proven to be important pillars of popular support. However, how long can authoritarian populists

remain in power? While the strong focus on the leader has proven to be part of the success story, how does it affect regime-survival in the mid- and long-run? What strategies do oppositional forces use to develop to beat the ruling parties in elections? Is the opposition to competitive authoritarian regimes democratic? The round table will discuss the future of authoritarian electoral regimes and the chances of oppositional movements in a comparative perspective, including examples from Turkey, Tunisia, the Western Balkans, Central and Eastern Europe and Latin America.

Sophie Reichelt

In January and February 2024, Sophie Reichelt conducted field research in Melilla to examine the impact of European and Spanish migration policies. She conducted eleven interviews with representatives from (I)NGOs, IGOs and civil society organizations, visited the CETI reception center and participated in a memorial action for the victims of the Nador-Melilla massacre. Expanding her research to the Moroccan side, she explored cross-border migration issues. Her study aimed to capture the complex realities migrants face and the strategies local actors employ in response to European border policies. Central to her inquiry was the question: Can these organizations effectively drive change amid increasingly restrictive migration measures?

Johannes Späth

In November and December 2024, Johannes Späth conducted field research in Cairo, Egypt, focusing on human rights governance within an authoritarian context. His research centred on the Egyptian National Council for Human Rights, with particular attention to the institution's mandate, operational scope, and capacity to effect change. Through a series of individual and group interviews with Council members, he assessed both the constraints and potential for institutional agency, identifying areas where targeted capacity-building—particularly through Austrian support—could be of value.

In coordination with the Austrian Embassy in Cairo, Johannes also facilitated dialogue around the Austrian probationary system, presenting it as a case study relevant to ongoing discussions in the

Egyptian parliament concerning penal code reform. This exchange supported the Council's broader efforts to inform and influence legislative debate, offering comparative insights into alternative approaches to criminal justice and rehabilitation.
